<b>First Day of School August 14, 2024</b>	Tuition Due on August 12, 2024 Books Fees for Pre-K, KG & 1 <sup>ST</sup> Grade	Parent must pay 2 weeks in advance in cash, credit card, on-line or money order and then bi-weekly payments thereafter in order to begin school.
<b>End of Fiscal Year December 31, 2024</b>	December 27, 2024 (See Bi-Weekly Tuition Payment Schedule) 2024-2025	Child will be suspended on January 2, 2025, and cannot return until the balance is paid in full. Tuition payment schedule must be adhered to upon return.
<b>Stanford 10 Test Kindergarten Only April 21 - 25, 2025 (Tentative Date)</b>	February 23, 2024 - <b>\$60.00</b>	Your child will not be tested and should stay home up to 3 days, or for the duration of test (that week full payment is due) as scheduled.
<b>Cap &amp; Gown Fee Cap &amp; Gown, Pictures (Kindergarten Only)</b>	March 21, 2025	Your child will not be included in the class pictures. Parents select the package and amount accordingly.
<b>Re-Registration On-line and/or In-Person March 1, - 31, 2025</b>	<b>March 1, 2025</b> \$160.00 – Infants to 3 yrs. \$260.00 – 4 yrs. & above <b>After March 31, 2025</b> \$200.00 – Infants to 3 yrs. \$300.00 – 4 yrs. & above	Space for the upcoming school year may not be available. \$160.00 fee charged to re-register children under 3 years and \$260.00 for four and above.
<b>*End of School Year 4-Year-Olds, Kindergarten &amp; First Grade Only June 6, 2025</b>	<b>(See Payment Schedule)</b> All accounts must be paid in full by Bi-Weekly - May 14, 2025	The child will be suspended (no records will be released) and will not graduate until fee is paid.  Bi-weekly - May 20, 2025
<b>Summer Activity Fee - TBA 2-year-old &amp; Above</b>	March 2025	Child may not begin Summer Program.
<b>Friends of Quality Time Inc.</b>	<b>FOQT (P.T.O.) Contribution</b>	<b>Minimum \$10.00 Contribution from Parents</b>
